#### Remarks from team A (Namur 1)

Quand la déclarante [Sud] a demandé "cœur" (qui veut normalement clairement dire le plus petit cœur du mort) j'ai [Est] marqué un temps avant de couvrir de mon 7 (au cas où la déclarante aurait changé d'avis "dans la même souffle").

### Remarks from team B (Cercle Perron 5)

Le contrat joué est 3SA. Après l'As de cœur, la déclarante a dit cœur. Petit cœur a été mis - à la table pour le 7 de cœur d'Est. Or elle n'y avait aucun intérêt à ne pas jouer le 10 de cœur.

### **Analysis**

If declarer designates a suit but not a rank, which is an incomplete designation, he is deemed to have called the lowest card of the suit indicated (except when declarer's different intention is incontrovertible) (Law 46.B.2).

With 10 - 9 - 6 in dummy and still a certain loser in that suit it is not <u>incontrovertible</u> that the declarer had a different intent at the moment he called for a heart (which might have been different with e.g. A - K - x and only one heart missing).

A played card may be withdrawn and returned to the hand without further rectification after a change of designation permitted by Law. This means that declarer may correct an unintended designation of a card from dummy until he next plays a card from either his own hand or from dummy. A change of designation may be allowed after a slip of the tongue, but <u>not</u> after a loss of concentration or a reconsideration of action. (Law 45.C.4.(b)). Here there is no slip of the tongue and it could very well have been that for a split of a second the declarer lost concentration when calling for a heart.

#### **Decisions**

The score on board 8 (in the closed room) of 50 for EW is maintained. The result of the match Namur 1 – Cercle Perron 5 remains 68 – 69 in IMP or 9,78 – 10,22 in VP.

Both teams can file an appeal against this decision. Please refer to the regulations for the treatment of an appeal, which can be consulted on the website of the RBBF.
