Remarks from team A (BBC 1)

East opened 1 vith only 6 HCP. They think that is not allowed.

Remarks from team B (U.A.E. 1)

A weak lead directing opening bid in 3rd hand is just 'normal' bridge.

<u>Analysis</u>

After the match had finished, I was asked by NS if an opening like this is allowed. According to the regulations, if 1 v by agreement can be opened with less then 8 HCP, it is a Yellow system. There is no evidence this is an agreement in this partnership. According to their statements, it is the first time East has opened this light, playing with this partner.

This $1 \bullet$ is <u>not a</u> so called <u>psychic bid</u>. A psychic bid should deviate from agreements in strength and/or length from the agreements.

Decision

A one (or first) time deviation from announced methods should not lead to a score adjustment. However, even in 3rd hand the regulations according to Yellow systems apply, as the regulation <u>does not</u> mention the regulation does not apply in that position. When this player/pair should once more open this light within the near future, the TD should consider this being a habit not disclosed through the system card. But if disclosed it would be considered Yellow, hence not allowed and a score correction would then be appropriate.
